"This pretty and commodious building is three stories in height with a handsome tower, which commands a view of the city of Victoria... this is the handsomest courtroom south of Dallas, and is furnished with luxury and taste...Here is where the district judge and his colleagues dispense justice to the 'wild and wooly' and to the innocent victim...

Quote taken from the Victoria Daily News, August 1893.

The original 1849 courthouse serving Victoria County, was replaced in 1892 by the Romanesque Revival structure designed by J. Riley Gordon.

Gordon is known as the "father" of Texas county courthouse architects. By the time he left Texas in 1903, he had designed sixteen county courthouses for Texas.

The 1892 Courthouse was restored to its' original grandeur in a seven year project which culminated on March 24, 2001 with a formal dedication.
