# LEGISLATIVE UPDATE

On August 28th De-Go-La RC&D hosted a Legislative Update. Guest speakers were William Moreno, field representative from Congressman Rubên Hinojosas office, (dist. 15), State Senator Judith Zaffirini (dist. 21), and Judy Hawley (dist. 31). Each speaker addressed issues which are concerns for rural communities such as: legislative influence, rural health care

healthcare, and nature tourism. There were 33 people in attendance. Judy Hawley went over House Bill 7. She called it a land mark piece of legislation, which will incorporate a de-centralized rural health incentive agency. Judith Zaffirini covered the issue of redistricting, she brought to the attendees attention the effects it will have on rural communities and the amount of influ-

Rural communities will have in the Legislature. William Moreno addressed such subjects as NAFTA and the I-69 corridor. He also covered topics relating to rural healthcare and rural infrastructure.

The Legislative Update was a success. De-Go-La would like to thank the public officials whom participated.

# TEXAS LEGISLATURE

The meeting of the 77th Texas Legislature which adjourned on May 28th enacted a variety of environmental laws. Chief among them was House Bill 2912 which will continue the missions and programs of the Texas Natural Resource Conservation Commission for another 12 years. This bill will establish new responsi-

bilities and requires the TNRCC to form new policles for compliance and enforcement of issues.Also passed was Senate Bill 5, the Texas Emissions Reduction Plan. This bill approves a variety of programs designed to cut pollution created by cars, trucks, and diesel construction equipment.

Funding for SB 5 will come from surcharges on the sale and lease of construction equipment and heavy diesel trucks, surcharges on heavy truck registrations, higher inspection fees for commercial vehicles and increased registration fees for vehicles new to Texas. SB 5 also established the

Diesel Emissions Reduction Incentive Program. This program provides grants to offset the incremental costs of projects that reduce air pollution from heavy trucks and construction equipment. Reauthorized and extended was the Petroleum and Storage Tank Remediation Program. The TNRCC has begun work on the implementation of these and other Bills.





As we move toward the end of the year a lot has happened. The events of September 11th have certainly effected us all in some way.

It has been a busy year for us in the Texas Leg-islature. We were not able to tag on to the Texas Dept. of Agriculture as we

had planned, but the passing of House Bill 7 will give us opportunities to work on more projects and receive more funding for them. As of this time I do not have the names of the nine people on that board, but they should be appointed soon. The U.S./Mexico RC&D Border Coalition meeting that was held in Tucson Arizona on Sept. 27-29 was postponed due to the events of Sept. 11. It will be held at a later date. Hope to see everyone at the Annual Meeting on October 6.

## RC&D PROJECTS THROUGHOUT TEXAS

On January 4, 2001 Dan Glickman, Agriculture Secretary, appointed 33 new areas in 25 states as RC&D areas. One of the 33 is the Chihuahuan Desert RC&D which covers 6 counties stretching from the Big Bend National Park to the New Mexico border, Mark Donet is the coordinator for Chihuanhuan Desert RC&D. Thus far Chihuahuan Desert RC&D has sponsored a Resource Team and other community improvement projects in their area of service. Big 8 RC&D, in cooperation with The Texas Dry Hydrant Com-

mittee assisted in a workshop to update participants of the progress and regulation changes in this field of service. De-Go-La RC&D planned to host a Resource Team for Calhoun Co. In wake of terrorists attacks this was canceled to a later date.

 If guests did nothing, full service was given.

In doing this the Inn saved: 2446 gallons of water = to enough water for 244 households for one day.

25 kilowatts of electricity = to the daily energy use of one household and the source of 7 pounds of air pollution.

Enough cubic feet of natural gas to operate the machines

and

17 pounds of laundry detergent.
